
Squirrly Affiliate Program



Squirrly comes with a SEO solution for **any Wordpress site**.

The plugin loads fast both in the frontend and the backend, and it contains all the features required by search engines and social media.

With all the features activated, Squirrly's **loading time is under 0.05 seconds.** It also **removes all Meta duplicates** made by other SEO plugins.



Squirrly needs remote access connection to our API, and the user has to confirm the connection with the default email address, or a custom email address.

When the connection is established, we link the user's email to the theme.

The user can then **use all the SEO features** from Squirrly **for free,** and the Content Optimization features as well (Keyword Research, SEO Live Assistant) up to **5 articles and 5 keyword researches**.



When the user buys a monthly subscription, he will receive the information in the affiliate panel in https://my.squirrly.co.



According to the affiliate commission, the user will see how much money he has to receive from us every month, and how much we've already sent.

You will be paid by Squirrly in your Paypal account, which is the only acceptable method for you to receive money from us.

For each customer you refer to us, based on your assigned commission, you will receive money in the next month after the referred customers made the payment. You will receive a commission from them on every single payment for subscriptions to Squirrly that they make. Basically, you get paid a commission on each recurring payment that referred customers make to Squirrly.

There is no fixed date for when the payments go out.

We take the responsibility of helping you with answers to your questions and inquiries for getting paid.
